## News and Report from our Grand Prior

I hope you all enjoyed your summer and had a chance to enjoy some time off and relax. Some of the Priories had events during the summer and you can read about them below.

On the international front, the next OSMTH Grand Magistral Meeting will be in Cologne, Germany at the end of the month, with a few Canadians attending. One of the agenda items will be the approval of new Regulations and Orders as well as new Statutes. This will bring some greater standardization to our Order. OSMTH has had significant growth in the number of Grand Priories over the last decade; growing from a few predominantly English speaking countries to over 20 multi-lingual countries, each with their own traditions and organizational nuances. With this has come some challenges on our internal governance. Once all is finalized, they will be part of the framework to revise our own Canadian orders.



Another challenge of our relatively young organization is the collection and distribution of charitable funds. As has been stated in previous newsletters, our Canadian Revenue Agency is just one of many countries changing laws and making it more difficult for legitimate charities to operate. We

(OSMTH) have been waiting on the European Union to show some guidance on how they were going to tackle this similar issue. One would think this an easier task to have the EU show leadership to the rest of the world, but apparently not. At the end of last year, the 28 Member States of the EU failed to agree a consensus on moving the draft legislation forward, and the EU Commission and Presidency have therefore now removed the draft law from the EU legislative agenda in 2015. "While the not-for-profit / charities sector across the EU still appears to be lobbying for the draft legislation to move forward, it may now be several years before the EU's legislative processes pick this up again". This lack of consensus is causing OSMTH to re-think its own projects. This too will be discussed in Cologne.

Although the world is getting more complex and mayhem is the news every day, do not despair. Get involved. It is surprising how much influence one person can have – both positively or negatively, on the world stage. None of the problems will be solved overnight but bit by bit we can all make our own communities, Canada, and ultimately the world a better place.

## **Editors Letter**

As always I am providing reports on international news and a Canadian update. When it comes to International stories these are intended to make you think about what is going on in the world. There is constant news in the European media about the many refugees from the Middle East and Africa trying to get into Europe. While many reports are depressing I think you also have to consider the larger picture and look at two main situations. (1) Many of these refugees are economic and thus want to improve their lives by getting into Europe. (2) Many refugees are fleeing horrendous conditions in their own countries and just want to be safe.

Of the second kind I think a much better policy needs to be worked out on how we can welcome them and in the longer term find a way for them to return to their own homes by settling disputes in their home lands. Many of these types of refugees do actually want to go home if they can do so and live in safely. I note that many news items quote refugees as paying \$1200 to get transported to Europe. That kind of money would purchase you a flight to Europe but it's the visa entry permit that prevents this method being used. Perhaps there is a way around this?

On the Canadian Update this issue I am just highlighting some interesting news on what Canada is doing but nothing like the last issue where I was trying to show how Canada is engaging with the world.

Other items that I thought might be of interest are ones that provide a religious and educational theme such as the story I provide this issue on "Ministering Children" which gave me pause on how we educate our children and I am giving you the first chapter of this book to read here.

As we're a religious organisation I thought I should provide some religious material for you to read so included a Religion section in this newsletter. Let me know if this is of interest and I can continue it in future issues.

Again my thanks to our Knights and Dames for sending in articles or suggesting ones for me to cover and I hope you enjoy this issue. I'll be at the St James Priory Investiture in September so feel free to say hello and make any suggestions as to what you'd like to see in future issues. #### Home Security

I asked Nick if he could provide some tips on home security and he kindly sent in a graphic that they use internally. I extracted the information and so here is the advice...

DO make sure all doors and windows are locked and fastened. Doors should have deadbolt locks.

DO examine your house from the street and make sure no valuables, like expensive electronics or artwork, are visible from the street. If a passerby can see your belongings, so can criminals.

DO secure sliding glass doors by placing a metal rod or piece of plywood in the track to prevent an intruder from forcing the door open.

DO secure doors with glass panels with deadbolts on the inside that can only be opened with a key.

DO unplug the power to your automatic garage door to keep thieves from opening it with a universal remote.

DO lock the door to your attached garage. If the garage door lifts on a track, a C-clamp tightened on the track next to the roller can prevent the door from being opened.

DO make it appear that you're home - use timers on lights, radios, and televisions.

DO keep the perimeter of your home well-lighted. You can do this by installing low-voltage outdoor lighting.

DON'T leave a message on your answering machine saying you are on vacation.

DO leave the air conditioner on. A silent compressor on a hot day is a good indication you aren't home.

DON'T leave clues that you are away. Ask a trusted neighbor to pick up your newspaper and your mail instead of stopping service, which lets people know that you are gone.

DO ask that person to put your trash containers out for pick-up and put them back again when they're empty and park their car in your driveway occasionally to give your home a more lived-in look.

DO have your lawn maintained if you will be gone for more than a few days.

DON'T close your blinds when you leave on vacation if you usually keep them open. The more normal your home looks, the better.

DON'T post the details of your vacation for the whole world to see. Refrain from discussing your trip on social networking sites. It's like setting up a sign letting criminals know your house is ripe for the picking!

DON'T leave a portable GPS in your car when you use long-term parking at the airport. It'll alert thieves that you're not home and give them a convenient map to your house.

DO keep track of all the keys to your home and make sure they're in safe hands. Locking your doors is important, but up to 50 percent of burglaries involve the use of a key.

DON'T hide a key outdoors in a protected spot, either. Burglars know the best hiding places better than you do.

DO frost or cover your garage windows, burglars won't be able to tell if your car is gone.

DO consider installing a Reilly's home security system, and make sure it is activated when you leave. Recent studies have shown that homes without a working home security system are 300% more likely to experience a theft.

Often comments we hear from potential postulants and pages is that I had no idea that there was such a variety of people attending this "soup kitchen". It is one of the event that we typically ask any potential postulant to come to before deciding to join the order. We have tried to make this a bimonthly event but we have all been exceptionally busy these past few months and as such its moved to a quarterly event.

We also had planned to assist Valour house here but due to some internal scheduling conflicts those events were postponed due to extreme guests of Valour house with very severe PTSD. We still remain willing and able to assist but are waiting on a green light to help with that organization. For any one curious Valour house is a home for military and first responders to house themselves during difficult times within their families. Think Ronald McDonald house for the military and first responders.

We had also been looking forward to working with STAR's air ambulance charity through a gala event this spring but due to downturn in the economy the event was cancelled due to lack of funding and poor support. We are looking at a few other charities to help but those are in the evaluation stages at this point.

So our tentative investiture date will be Late Oct early Nov with our hope of having the group move into priory status so to that end if you know of anyone in the Alberta area Edmonton or Calgary lets us know and we would be more than happy to reach out meet and greet and introduce them to the group. I will send around and email to all of the priors once we have confirmed a date with the Grand Prior.

# AN OPEN LETTER TO WORLD LEADERS FROM A BISHOP IN JERUSALEM AND A REFUGEE

1 September 2015 Jerusalem

Dear leaders of the world and people of good conscience,

I write to you from Jerusalem to address the very serious refugee situation affecting countries across the Middle East and now Europe. I myself am a refugee, as well as a bishop. Both my faith and my history oblige me to speak up for these women, men, and children who are washing up on beaches, are found decomposing in trucks on the highway, are crossing borders of barbed wire, and are barely surviving in makeshift camps. The last weeks have seen not only an increase in the numbers of these refugees, but also an increase in tragic outcomes for many. This is a shameful situation, and one which the international community cannot ignore. It must be remembered that refugees are not vacationers. They did not leave their homes because they were looking for adventure. They are displaced as a result of poverty, violence, terror, and political conflict. Frustration and fear lead them to risk their lives and their life-savings in search of safe havens where they can live and raise families in peace. We must remember that these are not "waves" or "masses" or "hordes"—these are human beings who deserve dignity and respect. As a refugee and as Bishop of the Evangelical Lutheran Church in Jordan and the Holy Land, I have two messages for world leaders:

I believe it is the responsibility of the world community, including the European Union, to have a clear policy to accept the stranger among us. "Welcoming the Stranger," a set of affirmations from faith leaders developed in collaboration with the UN High Commissioner for Refugees, is a good place to begin and a good model to follow. Most major religious traditions in the world advocate welcoming the stranger, showing hospitality to all. In Matthew 25 Jesus says the nations of the world will be judged by how they treat the poor, the hungry, the immigrant: "And when was it that we saw you a stranger

and welcomed you?' And the king will answer them, 'Truly I tell you, just as you did it to one of the least of these who are members of my family, you did it to me.'"

All political leaders are responsible for this current refugee crisis, either directly or indirectly. This is the result of a global system, not merely a local crisis. The international community has not helped solve the conflicts in the Middle East and North Africa, including the Palestinian-Israeli conflict. Economic and political interests have taken priority over peacemaking and dialogue. Our region has become so chaotic that it opens the door to extremists and terrorists; our people are becoming desperate. The Middle East needs justice and peace, not only to end the flow of refugees, but so that displaced people can return to their homes in dignity, and live in free democratic states. My words may be strong. They may be direct. But this humanitarian crisis requires even stronger actions. These people, our brothers and sisters, are crying: "Who will welcome us? Where is justice?" God hears the cries of the poor, the oppressed, and the refugee. I pray that soon, political leaders and policy makers in the Global North will also hear their cries. This will begin when leaders approach refugee communities not merely as problems to be solved, but as fellow children of God deserving accompaniment, dignity, and human rights.

For this reason, I urge all world leaders and people of good conscience to act quickly, for the sake of the humanity we share.

#### 29th Session of the UN Human Rights Council Agenda Item 4: Joint Oral statement, 24 June 2015 Speaker: Budi Tjahjono – Franciscans International

Thank you Mr. Chairperson,

This is a joint statement of 15 NGOs. We would like to draw the attention of the Council to the urgent need to address Climate Change from a human rights perspective. The HRC is the only international mechanism that has the competency to fully and comprehensively address the human suffering we are witnessing today, and that will increase in severity from now until at least 2030 or 2040 due to the effects of climate change.

In December of this year the UNFCCC will meet in Paris. It is from there that the international community, especially those who are most immediately and adversely impacted by climate change, hopes that leadership and widespread support for global cooperation will emerge. The future of humanity and our earth, as we know it, is at stake.

We welcome the Council's Panel Discussion on Climate Change and Human Rights in the March 2015 Session. Most panellists agreed that it is important to put a human face on the impact of climate and to address climate-related migration. Delegations called for mitigation and adaptation efforts to combat climate change that place people at the centre, are gender sensitive and ensure that the rights of the most vulnerable, including women, children, elderly, indigenous peoples and the poor are being upheld.

We also welcome the report prepared by four Council rapporteurs to inform the UNFCCC of the effect of Climate Change on the Full Enjoyment of Human Rights. It reaffirms that climate change can and does adversely affect the enjoyment of a broad range of human rights, especially the right to a safe life, to the highest standard of physical and mental health, to right to food and nutrition, to water and sanitation, to adequate housing to self-determination and in relation to the rights of those who are particularly vulnerable.

In this session, the Council will consider the adoption of a resolution on human rights and climate change. The on-going call from civil society members that was first expressed in the Council Social Forum in 2010 is still relevant today; the adverse impact of Climate Change on the full enjoyment of Human Rights must be addressed without delay. More than ever the Council should have the issue permanently on its agenda and should establish a mandate for a UN Special Rapporteur on Human

Rights and Climate Change to assess its impact on the full enjoyment of human rights.

The mandate would allow for country visits, the reception of communications from victims and affected communities, the collection of information regarding good practices including international cooperation, and solidarity in the field of combatting climate change. Thank you.

#### Join Us to Pray for Peace on September 24th, 2015

Starting in December 2012, a number of religious organizations in the Holy Land decided to hold a prayer vigil on the 24th of every month for Palestinians and Israelis until violence ended and a just peace was announced to end the Palestinian-Israeli conflict.

#### From the Office of the Grand Priory Chaplain General: Fr Michael Brain

St. Bernard of Clairvaux Born 1090 died 20th August 1153.

Bernard was born in south-eastern France in the year 1090 to a noble family.

The gifted 3rd son of a family of 7 children, he showed great aptitude during his studies with the secular canons (teachers) during his time as a student at Saint-Vorles.

In 1111, four years after the death of his mother, he withdrew from the world, and with his brothers and other relatives, entered the Abbey of Citeaux. He attracted a following, and eventually was asked by his superiors to found a monastery near Aube, in the region of Clairvaux (the Valley of Light).

He was not only a gifted writer, but a great speaker, and his wisdom was often sought by the Church leaders. Bernard preached his devotion to Christ and the Blessed Virgin Mary, and was one of the early learned men to preach against schisms within the faith and the spreading of heresies across parts of France.

In 1128 about 10 years after the founding of the Knights Templar, he was empowered by the Council of Troyes to formulate and write a Rule for these spiritual soldiers of Christ.

Following this, the Order grew and spread rapidly across Europe.

Bernard died in 1153, and his relics are Clairvaux, but his skull is venerated in the Cathedral of Troyes. He is the Patron Saint of the Templars; Gibraltar; Queens College, Cambridge; candlemakers and other groups.

"Unless you take up your cross and follow me, you have no part with me". St Matthew's Gospel 16 v 24).

St Bernard also took the side of the Jews who were suffering persecution in the Rhineland, and today persecution is happening to many religious faiths, all of whom we should pray for.

The world needs peace, and as well as our regular prayers for the Ukraine and the Holy Land, remember that the might of murdering terrorists is spreading its evil shadow of death constantly. #### Anti-Human Trafficking on OSMTH Agenda

Anti-Human trafficking was adopted as an authorized program by OSMTH International in 2010 after the issue was led and championed by then OSMTH Secretary General Simon Comte de Saint-Claire. Secretary General Saint Claire working within the United Nations UN.GIFT program participated with global agencies and OSMTH Grand Priories to generate local Priory awareness on Human Trafficking.

Brother Kim Derry, of the Priory of St. James in Toronto and former Deputy Chief of Toronto Police Service, joined the Order in 2014. Brother Kim is a world leader in coordinating agencies in the fight against Human Trafficking and in 2015 will found a new international non-governmental agency called GREAT. Working with Kim both as a senior Toronto Police Service member and co-founder of GREAT is a 2015 Postulant to the Priory of St James, James Brown.

The organization is in the charitable incorporation process in Canada under the name of Global Research Epicenter Against Human Trafficking (GREAT). It is not a foundation but an active charitable (non-governmental) organization addressing the worldwide need for a borderless, multi-sector resource and coordination center to combat Human Trafficking. It will assist countries and victims by identifying the limitations of resource availability, mandates, research and scope at most international agencies including INTERPOL, UNODC and EURPOL that have presented them the opportunity to design and implement this global resource center.

GREAT is a milestone of years of development and progress of organizations including "Together Let's Stop Traffick" (<u>http://www.togetherletsstoptraffick.org</u>), the FBI NAA (National Academy Associates), and the International Police Training Institute (IPTI). They are respected leaders representing international business, law enforcement, and NGOs and have become the foundation of the GREAT organization. There are approximately 100 individual contributing expert resources that are shaping the startup of GREAT.

Mission priorities are: 1) A comprehensive real-time intelligence database of ongoing international human trafficking organizations, programs, and resources. 2) A robust set of modern analytical tools to facilitate analytical support and information sharing with governmental, intelligence, law enforcement, and non-governmental agencies. 3) The development and maintenance of a repository of effective governmental policies, legislative frameworks, investigative procedures, and processes combatting human trafficking. 4) Sponsorship of Human Trafficking research and development projects. 5) Increased levels of rescue and recovery of victims through global coordination and a compendium of victim support resources. 6) Advancing public awareness and education of human trafficking in all its forms in order to reduce levels of victimization.

The success measures of GREAT will be the demonstrable impact to 1) Public and private awareness of human trafficking activities, trends, risks, and indicators. 2) Law enforcement dismantlement of human trafficking organizations. 3) Prosecution of human trafficking operators and enablers. 4) The rescue and reintegration of victims of human trafficking in all its forms. 5) Legislative progress.

The new non-governmental organization will increase knowledge, promote research, improve professional skills, and provide information sharing and analytical support to the global fight against Human Trafficking.

Brother Stuart W Ross, of the Priory of St James and Deputy Secretary General of OSMTH International has joined Brother Derry in the GREAT Initiative as Vice Chairman and a founding partner.

Deputy Secretary General Ross has very recently outlined the mission and principals of GREAT to OSMTH International leadership where he received a very strong endorsement from the Grand Master and Grand Commander in his proposal for OSMTH to reinvest in the anti human trafficking mission and negotiate a working partnership with the new GREAT organization.

#### How Europe turned its back on humanity

Europe holds dear the tenets of tolerance, freedom, and human rights - except when it comes to migrants.

When talk turns, as it often does, to the issue of defining Europe's identity and values, its handling of the current "migration crisis" has to be one of the core concerns.

For a continent that collectively holds dear such tenets as tolerance, freedom, and human rights, how does Europe square those with its current approach in dealing with mass migration?

We are facing the largest movement of refugees since the World War II.

The number of people forced to leave their homes rose to a record 60 million last year - with most of those people fleeing Syria's horrific war or coming from counties such as Afghanistan, Eritrea, Somalia, and Iraq.

For some time now, the news has been of migrants making the most appalling and terrifying journeys and all too often dying in the process.

But the European response so far has been to vilify the people risking everything to get here, while fortifying borders: building more walls, erecting more fences, sending more militarised patrols, and raising the possibility of bombing the "death boats" that make those perilous journeys across the Mediterranean into Europe.

#### Overwhelmed by the crisis

There is no debate around the billions of euros spent building and guarding borders against migrants and refugees - no question that this money might be better allocated.

Instead, Europe seems to have swallowed wholesale the idea that it is about to be "swamped" by "illegal" migrants, overwhelming us with their filth, extremist terror, and less developed cultures.

Sometimes it is politicians using those damning, demonising words - such as British Prime Minister David Cameron describing people trying to get to the UK from a migrant camp at Calais as a "swarm".

In reality, most refugees aren't trying to get to Europe: There were 626,000 asylum applications across the EU's 28 member states - and a collective population of 500 million - last year.

The UK has committed to take in 500 Syrian refugees, of the four million fleeing the war in that country.

Lebanon, meanwhile, has taken in over a million people from Syria, while Turkey, with around two million Syrian refugees, is hosting the highest numbers.

But in Europe, at a politics and policy level, discussions focus on the concern that being somehow more "lenient" to migrants - by absorbing more, say, or by creating safe, legal migration routes, so that people trying to get to Europe don't end up dying, horribly and avoidably - will give electioneering ammunition to the far-right.

#### Dragged into hostility

Apparently, Europe is so troubled by an influx of dark-skinned foreigners, so enthralled by intolerant positions on migration, that liberal policies on the issue would actually be vote-losers.

But is this really where we want to go - allowing Europe's racist far-right to drag us into an ever more hostile response to a humanitarian crisis? Are these the values we have decided should define us now?

Across Europe - and with the exception of Sweden - it seems that the countries that have the lowest levels of migration are the ones where anti-immigrant parties are better represented in parliament.

It is pure ignorance that is fuelling this sentiment - and yet, instead of challenging these views, politicians are pandering to them.

As the walls go up around the borders of "Fortress Europe", they have blocked our capacity to see connections between our policies and the people living beyond our fortified frontiers.

For it seems that when the West gushed about free market globalisation, it was only intended as a one-way street: We get the cheap goods and the forcibly opened markets, while those in the developing world get the broken economies, the corrupt governments and the failed states that so often arise as a consequence.

Creating stability and security

And when we talked about creating stability and security, we only meant for us - not for those in countries whose repressive dictatorships we are supporting and bankrolling and furnishing with ever more effective weaponry.

It is ravaging, ideologically driven austerity that has crashed living standards across Europe, decimating public services and welfare, causing worry over resources and access to them.

And when we insisted military "interventions" in Iraq, or Afghanistan, or Libya, were humanitarian and liberating, we didn't plan or even think about the aftermath; the horrendous consequences that might follow.

Meanwhile, if neoliberal politics have created a staggering inequality of wealth, security and opportunity, it is now also informing our reactions to it.

After all, it is the logical response of neoliberalism - a rampaging economic ideology that puts profits before people - to see desperate migrants and refugees as an inconvenience to the smooth tickingalong of advanced capitalism: A disruption to the passage of goods; an inconvenience to the flow of tourism.

It is a race-to-the-bottom rationale that has decimated employment markets across Europe.

It acts to further ferment resentment, from people worried about insecure and low-paid jobs, towards migrants coming into the workforce.

Desperate for life

The real target for both groups should be the employers who keep driving down wages, and the governments that allow them to.

It is ravaging, ideologically driven austerity that has crashed living standards across Europe, decimating public services and welfare, causing worry over resources and access to them.

People don't risk death unless they are desperate for life.

People don't usually decide to violently uproot families and lives unless that is the only choice available to them. Rather than dream of Europe, refugees often wish to return home, if they could.

In the endurance of long, dangerous journeys, in the resourceful capacity for survival, in the courage and tenacity of attempts to cross borders, in the persistence of a propelling, perpetual, hopeful life

force in the face of unimaginable adversity, what people trying to get into Europe are repeatedly showing us is humanity.

And what we are showing, repeatedly, is that we have lost ours.

#### Canada's response to the situation in Syria

Since the start of the Syrian uprising in March 2011, Canada has worked to support the Syrian people. Canada has been active in calling on the international community to come together and defend the rights of the Syrian people to determine its own future.

Canada has also contributed generously to the various international efforts to aid the Syrian people, including those living as refugees in neighbouring countries, support Syrian civil society and counter the threat posed by chemical weapons.

To date, Canada has committed more than \$700 million in humanitarian, development and security assistance in response to the Syrian crisis. This support includes the following.

Since early 2011, the unrest in Syria has led more than 3.8 million Syrians to seek refuge in the nearby countries of Egypt, Iraq, Jordan, Lebanon and Turkey, resulting in significant humanitarian needs. According to the United Nations Office for the Coordination of Humanitarian Affairs (OCHA), 12.2 million people inside Syria, including 7.6 million who are internally displaced, also need urgent help. It is estimated that more than 200,000 people have died in the ongoing conflict, with hundreds of thousands wounded.

Since January 2012, Canada has committed \$403.5 million to international humanitarian assistance in response to the Syrian crisis. This amount includes the \$50 million announced by Minister Paradis on January 7, 2015, for conflict-affected people in Syria and neighbouring countries, including Jordan, Lebanon and Turkey, and the \$150 million announced by Prime Minister Stephen Harper on January 24, 2014, as well as prior commitments. This assistance is delivered through experienced humanitarian partners in response to urgent needs, and it is contributing to significant results on the ground.

Canada has also expanded its commitment to help Syrian refugees by resettling an additional 10,000 Syrians by the end of 2017, bringing to 11,300 the total number of Syrian refugees Canada has committed to resettling. Canada will work with the United Nations High Commissioner for Refugees and private sponsors to resettle these Syrian refugees in Canadian communities. Visit Refugees and asylum for more information about Canada's refugee protection programs.

Canada has already committed \$230.7 million to support development projects in the region to strengthen government services and infrastructure stressed by the influx of Syrian refugees, specifically in health, education and the delivery of basic services, and to address Jordan's specific development challenges.

Canada has committed \$67.2 million in security-related assistance to address the effects of the Syrian crisis, including \$52.51 million for Jordan. These funds will help mitigate the threat of chemical weapons and other weapons and materials of mass destruction, assist Jordanian security forces in managing the non-humanitarian aspects of the influx of Syrian refugees and contribute to Jordan's counterterrorism capacity. This support also includes \$3.8 million in stabilization assistance to Syrian activists and civil society members in areas such as civil administration, accountability, independent media and secure communications.

#### Loyalty Pays Off: Unlike US, Russia Remains True to Its Arab Partners

Russia's loyalty to its Arab allies sharply contrasts with Washington's habit of abandoning its partners in the Middle East and could win Moscow new friends in the region, an Israeli news website focusing on investigative journalism asserted.

What's Behind Russia's Latest Round of Syrian Diplomacy?

Take Syria, for instance.

President Bashar al-Assad praised Moscow's policy toward Damascus as "principled" in a recent interview. "We have strong confidence in the Russians, as they have proven throughout this crisis, for four years, that they are sincere and transparent in their relationship with us," he noted.

Not surprisingly, Russia has recently stepped up its efforts to find a political solution to the ongoing conflict in Syria without forcing Assad to resign. The new peace initiative involves courting Arab nations. Moscow's logic is simple: Assad is not the enemy, Islamic extremists are.

"Russia's stance on Syria is rigid and consistent. President Putin has made it clear that Assad is Syria's legitimate president and Russia is against foreign involvement [in the country's affairs] which will force the Syrian people to accept certain conditions, like securing peace in exchange for Assad's resignation," the media outlet noted.

It is against this background that Russia suggested creating an anti-terrorist coalition, including Jordan, Saudi Arabia, Syria and Turkey. Vladimir Putin also tried to serve as a mediator between Assad and Saudi King Salman bin Abdulaziz al-Saud, but representatives of both sides failed to reconcile their differences during a recent visit to the oil kingdom, News1 noted.

Moscow's peace initiative also involved Egypt's President Abdel-Fattah al-Sisi, Jordan's King Abdullah II and Abu Dhabi's Crown Prince Sheikh Mohammed bin Zayed visiting Moscow last week. Sisi, according to the media outlet, could be interested in what Russia has to offer with respect to Syria. Cairo and Damascus are said to be getting closer to each other and could soon restore diplomatic relations.

But the key visit of an Arab leader to Russia has yet to take place. King Salman is expected to meet with President Putin in the near future. Both leaders will likely discuss the deal on the Iranian nuclear program and the fate of Assad.

"Russia's undivided loyalty to its ally in the Middle East has impressed Arab leaders and they are increasingly looking to Moscow in the hopes of receiving Russia's support, as well as signing new arms deals and economic agreements," the media outlet stated. "President Putin has shown that staying true to ones commitments pays off."

#### Russia to Deploy Naval Fighter, Surface to Air-Missile Regiments in Arctic

The command of the Russian armed forces in the Arctic will be enhanced by naval fighter and surface to air-missile regiments before the end of 2015, Russian Defense Minister Sergei Shoigu said on Monday.

MOSCOW (Sputnik) — Shoigu said that the necessity to enhance Russia's military presence in the Arctic arose due to the development of the Northern Sea Route and the need to protect national interests in the region.

## Paris Obliged to Negotiate Mistral Resale With Moscow

#### A tourist in the land of the ayatollahs

From ayatollahs railing against the Great Satan (aka the United States) to whip-wielding policemen on motorbikes, Iran hasn't presented the most inviting face to the outside world over the last few decades. But a few days ago the UK Foreign Office stopped telling travellers to avoid non-essential trips. So what's it like for a visiting foreigner? Amy Guttman shares her experiences.

I'm fairly fearless in far-flung places, but arriving in Tehran made me nervous. As a single, white female, I stuck out. I scanned the hall for my guide Amin, and didn't relax until I spotted his placard with my name on it.

British, American and Canadian tourists must be accompanied at all times by a guide. This meant Amin, short in stature, but long in kindness, would spend the next eight days with me - many of them stretching from dawn until late at night. Amin, with his warm smile, sharp sense of humour, and gentle nature became like a brother to me. He also became my accountant. Hotels, food and souvenirs are roughly on a par with American prices, but for an outsider working this out can be tricky - Iran uses the rial, but prices are often in toman, which equal 10 rials... Let's just say there are several zeros to contend with, and long-division skills are a necessity.

Hotels in Iran are like a time warp, circa 1979. That's when the Islamic Revolution forced the termination of all foreign hotel contracts. Nowadays, they're referred to by their former names, like "the old Sheraton". But despite the lack of modern amenities and contemporary decor, the hotels I experienced were very clean, and functional.

Breakfast is tea, dates, and watermelon, served with thick, sesame-topped flatbread and honey or quince jam, and sometimes whipped cream. Yes, whipped cream!

The only thing missing was coffee - good coffee. A government backlash against Western habits, such as socialising in coffee shops, has shuttered many of Tehran's cafes. A few good coffee shops

near the university and north Tehran remain, but even the strongest cup doesn't taste like a proper Americano. On the other hand, coffee drinking - and cupcakes in typical American flavours such as red velvet - are gaining in popularity. A Persian Starbucks would have bright prospects.

#### Most graduates 'in non-graduate jobs', says CIPD

In a previous issue I ran an article on the value of apprenticeships over university degrees. I came across this report on the BBC web site which tends to confirm this view.

The majority of UK university graduates are working in jobs that do not require a degree, with overqualification at "saturation point", a report claims.

Overall, 58.8% of graduates are in jobs deemed to be non-graduate roles, according to the Chartered Institute of Personnel and Development.

It said the number of graduates had now "significantly outstripped" the creation of high-skilled jobs.

The CIPD said the report's findings should be a "a wake-up call".

"The assumption that we will transition to a more productive, higher-value, higher-skilled economy just by increasing the conveyor belt of graduates is proven to be flawed," said Peter Cheese, chief executive of the CIPD, the professional body for human resources managers.

'Simply wasted'

The report found the issue was leading to "negative consequences" including employers requesting degrees for traditionally non-graduate roles despite no change to the skills needed for the role.

As a result, it found graduates were now replacing non-graduates in roles and taking jobs where the demand for graduate skills was either non-existent or falling.

The trend was particularly prominent in construction and manufacturing sectors where apprenticeships have previously been traditional routes into the industry, the report found.

Mr Cheese said that in many cases the "skills premium" graduates had "if it exists at all" was being "simply wasted".

The CIPD is calling for a "national debate" over how to generate more high-skilled jobs.

It said government and organisations both needed to act to help graduates make better use of their skills, but said the report also highlighted that for young people choosing an apprenticeship instead of university could be a "much better choice"

#### Finland considers basic income to reform welfare system

Over the years I've often considered this to be a way to help people while reducing the expensive social security system we have. And so when I saw this article on the BBC web site I thought I'd copy it here for you to think about...

The Finnish government is considering a pilot project that would see the state pay people a basic income regardless of whether they work.

The details of how much the basic income might be and who would be eligible for it are yet to be announced, but already there is widespread interest in how it might work.

Prime Minister Juha Sipila has praised the idea. "For me, a basic income means simplifying the social security system," he said.

The scheme is of particular interest to people without jobs. In Finland, they now number 280,000 - 10% of the workforce.

With unemployment an increasing concern, four out of five Finns now are in favour of a basic income.

Basic income

- Paid without any need for work
- Paid irrespective of any income from other sources
- Additional income subject to income tax
- Finland to initiate pilot project
- Dutch city of Utrecht to experiment with basic income this autumn
- UK Green Party advocated similar "Citizen's Income" at 2015 election

"A basic income? Yes, I'd gladly have €1,000 (£700, \$1,100) a month," says one man at a centre for the unemployed in Pori, near Finland's west coast. But the amount is unlikely to be anywhere near that high.

He is among the jobless who have come to an old, wooden building in city, where they can get cheap food, shop at a second-hand market, and take part in a variety of activities on offer.

"It's a nice place to socialise," says another man sitting on a bench outside, enjoying the summer sun. People here have been out of work for a long time.

"A basic income would encourage people to take a temporary job," says Paivi Hietikko, who helps out at the centre. Although she has no regular income at the moment, she does receive a payment for her work here.

"Having a basic income would mean the bureaucracy l've encountered at the employment agency would decrease."

In Finland, taking on work can cost you money if you are unemployed.

A paid temporary job means lower welfare benefits.

And if that job comes from a low-wage sector, you lose out because there is a delay before the authorities allow your benefits to be restored once you have left the job.

Fundamental change

Many Finns nowadays have what are described as atypical working lives, in that few spend their entire lives in the same occupation and with the same employer.

This fundamental change has prompted a need for reforms to the social security system.

Supporters of the basic income believe it could offer an alternative to Finland's complex and costly benefit models.

Paivi Hietikko certainly sees its potential advantages - but she also wonders whether it would deter people from looking for work.

The young especially might lose the motivation to look for a job, if it was, say, €700 a month. That would be too much," she says.

This has become one of the main concerns surrounding the idea.

But experts say it is too early to tell what the outcome would be.

"What would be the impact of a basic income to employment in Finland - positive or negative? We can't really foresee how people would behave with a basic income," says Ohto Kanninen, from the Tank research centre.

So the pilot project aims to get some answers.

#### Equality obstacle

The prime minister has expressed support for a limited, geographical experiment. Participants would be selected from a variety of residential areas.

Mr Kanninen proposes testing the idea by paying 8,000 people from low income groups four different monthly amounts, from €280 to €500.

"If the impact on employment during the experiment was catastrophic, basic income would of course not be implemented on a large scale," he says.

One obstacle to staging a pilot project is Finland's constitution, which states that every citizen must be equal.

Even a small-scale experiment would put its participants in an unequal position.

However, Finns may be prepared to waive that principle of equality, if an experiment produces valuable information for society.

#### Yemen crisis: How bad is the humanitarian situation?

The country is experiencing 'a humanitarian catastrophe'

That was the frank assessment of the UN's Humanitarian Co-ordinator, Johannes Van Der Klaauw, on 19 August.

Almost 4,500 people have been killed and a further 23,000 have been wounded since the escalation in March of the conflict between forces loyal to the exiled President Abdrabbuh Mansour Hadi and those allied to the Houthi rebel movement.

The destruction of infrastructure and restrictions on imports imposed by a Saudi-led coalition carrying out air strikes against the rebels have led to 21 million people being deprived of life-sustaining commodities and basic services.

#### Slower melting ice cream developed by scientists

Scottish scientists believe they have found the secret to making an ice cream that does not melt so quickly on hot summer days.

Researchers at the universities of Dundee and Edinburgh have found a naturally occurring protein that makes the ice cream mixture more stable meaning it melts more slowly and is smoother in texture.

Prof Cait MacPhee, from the University of Edinburgh, says the new ingredient will mean ice cream will "melt eventually, but hopefully by keeping it stable for longer, it will stop the drips".

## Canadian Update

#### ΝΑΤΟ

On 31st July 2015 Prime Minister Stephen Harper announced the extension of Operation REASSURANCE, Canada's contribution in support of the North Atlantic Treaty Organization's (NATO) Assurance Measures in Central and Eastern Europe, until June 2016. Canada's continued support of NATO's efforts to promote security and stability in Central and Eastern Europe demonstrates the

Government's steadfast commitment to our Allies in the region.

It is also part of Canada's broader response to the Putin regime's aggression in Ukraine. Canada's position on Ukraine has been clear: we recognize the sovereignty and territorial integrity of Ukraine and will never recognize the illegal Russian occupation of Crimea or any region of that country.

Operation REASSURANCE refers to the military activities undertaken by the Canadian Armed Forces (CAF) to support NATO Assurance Measures through the provision of military capabilities for training, exercises, demonstrations and assigned NATO tasks.

Quick Facts

On April 17, 2014, Prime Minister Harper offered CAF assets to NATO as part of allied assurance measures to promote security in Central and Eastern Europe.

Since May 2014, Canada has maintained a regional presence of approximately 200 Canadian Army soldiers based in Poland. In total, more than 450 soldiers have deployed to take part in a variety of training exercises alongside NATO Allies and partners.

Additionally, Canada has maintained a maritime presence in the region with a rotational deployment of Her Majesty's Canadian Ships Regina, Toronto, Fredericton and now Winnipeg, including embarked CH-124 Sea King helicopters and their crews as part of NATO Standing Maritime Forces. During Operation REASSURANCE, the ships conducted maritime security operations and joint NATO training exercises in the region.

From May to August 2014, Canada contributed approximately 20 CAF staff officers to NATO's Supreme Headquarters Allied Powers Europe to assist with the planning of a number of defensive measures on land, sea and air.

From May to December 2014, in support of NATO Assurance Measures, the CAF deployed up to six Royal Canadian Air Force CF-18 Hornet fighter aircraft and approximately 200 airmen and airwomen as part of an Air Task Force. The Air Task Force conducted training with NATO allies in Romania and participated in the NATO Baltic Air Policing mission based in Lithuania.

#### The 2015 Canadian federal election

(Formally the 42nd Canadian general election) will be held on October 19, 2015 to elect members to the House of Commons of the 42nd Parliament of Canada.

The main parties contesting the election are the incumbent Conservative party, the Official Opposition, the NDP, and the Liberal party.

The election takes place with the background of a possible recession in Canada given that 20% of Canadian income comes from oil. The Loonie (the Canadian dollar) has also dropped some 20% in value against the US dollar which should increase exports but there is little sign of this happening at time of writing which is somewhat puzzling.

#### Truth and Reconciliation Commission

For over a century, the central goals of Canada's Aboriginal policy were to eliminate Aboriginal governments; ignore Aboriginal rights; terminate the Treaties; and, through a process of assimilation, cause Aboriginal peoples to cease to exist as distinct legal, social, cultural, religious, and racial entities in Canada. The establishment and operation of residential schools were a central element of this policy, which can best be described as "cultural genocide."

Physical genocide is the mass killing of the members of a targeted group, and biological genocide is the destruction of the group's reproductive capacity. Cultural genocide is the destruction of those structures and practices that allow the group to continue as a group. States that engage in cultural genocide set out to destroy the political and social institutions of the targeted group. Land is seized, and populations are forcibly transferred and their movement is restricted. Languages are banned. Spiritual leaders are persecuted, spiritual practices are forbidden, and objects of spiritual value are confiscated and destroyed. And, most significantly to the issue at hand, families are disrupted to prevent the transmission of cultural values and identity from one generation to the next.

In its dealing with Aboriginal people, Canada did all these things.

## The Magna Carta turns 800 years old on Monday. The trip from the U.K. to Ottawa-Gatineau is part of the anniversary celebrations.

"It's taken four years of intense negotiations. It's not easy to move a document like this. But once we were in negotiations, we felt it was something we wanted to do to celebrate the anniversary, and particularly seeing that the Queen wanted the Commonwealth included, this was an opportunity to do that," said Rev. Rosalind Brown, the Durham Cathedral's librarian.

"To understand how blessed we are to live here and now, you have to understand what the foundations of this country are, and this document was really the blueprint of many of the rights and freedoms that we enjoy here today," said Suzy Rodness, who, along with her husband, worked for several years to bring the Magna Carta to Ottawa-Gatineau.

She and Len Rodness are co-chairs of Magna Carta Canada, a charitable foundation that raised funds and established committees to bring the document to Canada.

The Magna Carta, also known as the Great Charter of the Liberties, was created in 1215 by England's barons to curb the arbitrary powers of King John I, according to Magna Carta Canada's website.

"It expresses four key principles: that no one is above the law, not even the monarch; that no one can be detained without cause or evidence; that everyone has a right to trial by jury; and that a widow cannot be forced to marry and give up her property — a major first step in women's rights," the website reads.

Also on display at the museum will be the Charter of the Forest, which was first issued in 1217 and complements the Magna Carta in more specific detail.

"It re-established the right of free men to hunt and farm in the king's royal forest. It also substantially reduced the area of the royal forest, which had accounted for roughly a third of England, and banned severe punishments for forest offences such as hunting protected deer," the website reads.

The Magna Carta will also travel to Winnipeg, Toronto and Edmonton until late December.

The new medal will elevate the way we recognize individuals who contribute to Northern communities and to our understanding of Northern Canada and its people. It will also highlight their achievements in polar exploration and scientific discoveries. The Governor General will preside over an inaugural presentation ceremony at a later date.

#### PM announces conclusion of Free Trade Agreement with Ukraine

Prime Minister Stephen Harper today announced that Canada and Ukraine have successfully concluded negotiations toward the Canada-Ukraine Free Trade Agreement (CUFTA). The bilateral free trade agreement will boost commercial ties between the two countries, creating jobs and opportunities for Canadians across Canada. The announcement was made just a few weeks after the Prime Minister's visit to Ukraine in early June, his third to the country since March 2014.

The CUFTA will provide improved market access for Canadian exports to the Ukrainian market, help address non-tariff barriers and facilitate closer economic relations. In addition, the CUFTA will provide Ukrainian exports with improved access to the Canadian market, which is consistent with the Government's unwavering commitment to support Ukraine's democratic transition and economic reforms.

Once the Agreement enters into force, Canada and Ukraine will immediately eliminate duties on 99.9 per cent and 86 per cent of respective current imports, thereby benefiting both Canadian and Ukrainian exporters and consumers. The Agreement will result in the elimination of all Ukrainian tariffs on industrial goods, forestry and wood products, fish and seafood products, as well as the elimination of the vast majority of Ukraine's agricultural tariffs. Canadian agriculture exporters will benefit from duty-free access for beef, pulses, grains, canola oil, processed foods and animal feed. Canadian pork

producers will benefit from improved access to Ukraine's market via a large tariff rate quota.

Prime Minister Harper highlighted the inclusion of Ukraine as a priority emerging market under Canada's Global Markets Action Plan and as one of Canada's development countries of focus. He also publicly released Canada's market access plan for Ukraine – another tool the Government of Canada is providing to help Canadian companies, especially small and medium-sized enterprises, identify new opportunities to do business in Ukraine.

The Agreement is informed by public consultations, and reflects the views and priorities of Canadian businesses, industry associations, provinces and territories, and other stakeholders.

#### Free Trade Agreement with Israel

Prime Minister Stephen Harper today announced that negotiations toward an expanded and modernized Canada-Israel Free Trade Agreement (CIFTA) have concluded.

The modernized CIFTA will notably provide expanded market access opportunities for agricultural, fish and seafood products through the reduction or elimination of Israeli tariffs on a large number of products, and duty-free access under tariff rate quotas for certain products.

Four existing areas of the current CIFTA have been modernized, namely market access for goods, rules of origin, institutional provisions, and dispute settlement. In addition, seven new chapters have been included in the areas of trade facilitation, sanitary and phytosanitary measures, technical barriers to trade, intellectual property, electronic commerce, labour, and environment.

This robust CIFTA will support Canadian businesses and investors, deepen trade and investment linkages, and further strengthen Canada's bilateral relationship with Israel.

A modernized CIFTA will facilitate expanded bilateral commercial flows by reducing tariffs and other barriers, enhancing cooperation and increasing transparency in regulatory matters. A modernized agreement also stands to reduce transaction costs for businesses and create new opportunities for Canadian agriculture, agri-food, fish and seafood companies in the Israeli market.

#### **Brook Henderson**

Canadian teenager Brooke Henderson earned her first LPGA Tour victory on Sunday and subsequently made a 15-spot climb to 17th in the new Women's World Golf Rankings released Monday.

After winning the Portland Classic by eight strokes to become the third-youngest champion in LPGA history at 17 years, 11 months, 6 days, Henderson has made more than \$660,000 US in 10 events this season and now ranks ahead of such luminaries as Michelle Wie, Karrie Webb and Morgan Pressel.

So much success, and yet Henderson doesn't even possess a tour card. Last year, the LPGA denied her an age petition to play in Q-school, so she has had to rely on sponsor exemptions and Monday qualifying to compete in tournaments.

But after Sunday's eight-stroke victory, the first by a Canadian on the LPGA Tour since Lorie Kane at the 2001 Takefuji Classic, Henderson is now assured of finishing among the top 40 in earnings, meaning she will get her card for next season, by which time she'll be 18 and eligible for one.

Of course I did highlight her amazing game in last quarters newsletter so good to see her going from

strength to strength. It is also probable that she will represent Canada in next years Olympics.

#### Canadian Dollar Hits 11-Year-Low Against U.S. Dollar

Greenback last hit this level in August 2004

The Canadian dollar sank against the U.S. dollar early Monday, hitting a new 11-year low as investors capitulated amid a broad selloff in global markets.

The U.S. dollar was recently at C\$1.3210 from C\$1.3187 late Friday, according to data provider CQG.



The greenback earlier reached as high as C\$1.3290, a level it hasn't reached since August 2004.

"There's certainly some panic out there," said Karl Schamotta, director of FX Strategy at Cambridge Global Payments.

Along with other commodity-linked currencies, the Canadian dollar was hit hard early Monday by plummeting oil prices. Crude prices fell to new multiyear lows amid lingering concerns about global economic growth, with the Nymex October contract down 4% to about \$38.84.

Interest rate expectations have diminished substantially across all major currencies, including the U.S. with economists now seen pushing back their forecasts for the next Federal Reserve rate increase to December.

"The reality is that we are looking at a global economy suffering widespread disinflationary conditions," Mr. Schamotta said.

The Canadian dollar, which is closely correlated to oil prices, reacted swiftly, as investors see weaker oil prices weighing heavily on the Bank of Canada's next monetary policy move.

"The rout in global equity markets is being magnified in Canada through the energy complex, and the combination of deteriorating financial conditions and weaker oil prices presents serious hurdles beyond the very near-term economic outlook," said Mark Chandler, head of Canadian fixed income and currency strategy at RBC Capital Markets.

The market is now pricing in about a 75% change of another 25-basis-point rate cut over the next 12 months, Mr. Chandler said.

With the Canadian dollar now hitting new lows, currency analysts expect the next major level for the U.S. dollar to climb to is around C\$1.3380, although C\$1.35 is a key figure that is within reach, Mr. Schamotta noted.

#### Recession confirmed as Canada's GDP shrank in 2nd quarter

Canada's economy expanded in June but declined by 0.1 per cent for the second quarter as a whole, meeting the bar of what is legally defined as a recession.

The economy expanded by 0.5 per cent in June, Statistics Canada said.

But that slight monthly uptick wasn't enough to offset the contraction in the previous two months, which means for the second quarter as a whole, the economy shrank.

The service sector expanded by 0.6 per cent between April and June, which helped offset a decline in goods-producing industries like oil and gas, and manufacturing.

While the resource sector continued its slide, shrinking by 4.5 per cent in the quarter, other industries expanded, including the public sector, wholesale trade and real estate agents, where economic activity expanded by a whopping 9.9 per cent.

Households also spent more during the quarter. Consumption increased 0.6 per cent in the second quarter, following a 0.1 gain in the first quarter.

Add it all up and Tuesday's data suggests "there was a recession," TD Bank economist Randall Bartlett said. "In our view, it was a very very mild one in the first half of 2015, but that's behind us now and all indications point to a positive growing economy for the rest of the year."

#### William Osler, The Man

WHATEVER may be said of Sir William Osler in days to come, of his high position in medicine, of his gifts and versatility, to his contemporaries, love of his fellow-man, utter unselfishness, and an extraordinary capacity for friendship will always remain the characteristics which overshadow all else. Few so eminent and so industrious come in return to be so widely beloved for their own sake. Most of us do well with what Stevenson advises—a few friends and those without capitulation —but Osier had the God-given quality not only of being a friend with all, high or low, child or grown-up, professor or pupil, don or scholar, but what is more, of holding such friendships with an unforgetting tenacity—a scribbled line of remembrance with a playful twist to it, a note of congratulation to some delighted youngster on his first publication, the gift of an unexpected book, an unsolicited donation for some worthy cause (and giving promptly he gave doubly), a telegram to bring cheer or consolation, an article to help a struggling journal to get a footing, a cable such as his last on the day of his operation to his old Hopkins friends, which was given by them to the press for the benefit of countless others

who shared their own anxiety—all this was characteristic of the man, whose first thoughts were invariably for others.

#### **Chinese Canadian History**

From the time Chinese first arrived in British Columbia in 1858 until 1874, they were like any other migrants: they occupied lower paid jobs. While people of Caucasian descent were paid \$2 a day, the Chinese accepted \$1.35 a day for the same work.

However, Chinese were also treated different than any other immigrants in two important ways: they were forbidden to vote until after WWII, and they were subjected to a head tax.

The Chinese were always considered "heathens" and by 1875 the government declared, "Chinese of the Province of British Columbia may not make application to have their names inserted in any list of voters and are disqualified from voting at any elections."

A decade later, in 1885 the Chinese became prey to a head tax. The head tax was designed to discourage Chinese from entering Canada. The tax started at \$50, and less than four decades later (1903) had risen to \$500 per person, a fortune at that time.

When World War I was declared in 1914, approximately 200 Chinese volunteered for the Canadian Army. Marjorie Wong in her book, The Dragon and the Maple Leaf, listed some of the men from British Columbia, including two brothers from Shuswap area: Wee Hong Louie and Wee Tan Louie. The widow of Wee Tan donated his helmet to the Chinese Canadian Military Museum which is on display.

Following the end of the first war, returning Chinese veterans continued to face racial intolerance as well as unemployment.

The next indignity was the passage of the 1923 Immigration Act, also known as the Chinese Exclusion Act. It was the only legislation written for a specific ethnic group. It effectively barred Chinese from Canada.

At the start of the World War II, a few Chinese volunteered for the Canadian Army. They were accepted and when the war moved to Hong Kong, more Chinese volunteered.

However, the air force and navy at first did not accept anyone of Chinese descent due to their internal policy. But that policy was eventually overturned as the war moved to the Pacific Theatre and Chinese were considered useful.

By that time, conscription was a big topic in Chinatown. Heated debates took place in church halls between various groups and organizations. "Should Chinese men and women volunteer or wait until the government called their names?"

Those who wanted to volunteer argued that if Chinese wanted to be considered first class citizens, they needed to demonstrate their commitment to Canada.

Those who were opposed volunteering replied, "Look at what the government has done to us. Why should we fight for a country that doesn't want us?"

In what amounted to a vote, the patriotic Chinese won the day.

They volunteered in all three branches of the armed forces and some were even seconded to the British forces. They fought on land, sea and air and some made the supreme sacrifice.

At the end of the war, in 1947, the infamous Chinese Exclusion Act was finally repealed. In the same year, the first Canadian citizenship ceremony for Chinese was held at the Commodore Cabaret in Vancouver with some 400 in attendance. Chinese were finally allowed to vote in the provincial election of 1949, followed by federal election the same year.

The return of the franchise also meant the professionally trained could take their place alongside their Caucasian colleagues. Chinese could now be recognized as doctors, lawyers and engineers. This meant these men and women could now provide a stable future for their children and in turn, change the economic landscape in the Chinese Canadian community forever.

Now in the second decade of the new century, today's Canadian Forces count among its members various ethnic group — including Chinese in the campaign in Afghanistan – who are making their contribution to Canada.

The children here have worked hard to graduate, and our teachers here in Jordan have worked hard as well. I was also able to give out gifts to the children as they came through the line to receive their certificates. We gave them crosses, bracelets, and sweets! They were so happy to receive our gifts, and it is truly a gift from G-d that we are able to minister to them in this way. We are sharing the love of Jesus with them.

We are working now on trying to expand our education project in Jordan to include two more schools, and we are hoping to partner with the Greek Orthodox School system as we do this. If we are able to move forward with this partnership, it would allow us to continue doing the work G-d has given us to do, but on a much larger scale!

We are also continuing to maintain our medical clinic here in Jordan, which allows us to provide much needed services to our people. AUGUST 14, 2015 Dear Friends,

Marhaba! (which is Hello! in Arabic). Today you are invited to come with us to the clinic that is supported by the Foundation for Relief and Reconciliation in the Middle East (FRRME). We have partnered with a clinic already in operation in Amman, Jordan, which is located within the neighborhood of Swafieh.

Many of the refugees from Iraq that we have been able to support reside within the community of Marka. This is a half hour ride away from our clinic. The families we support don't have personal transportation so we provide it for them. Three days a week our bus transports about twenty patients, making the clinic available for care and services to those who need it most.

These combined efforts provide Iraqi refugees, often with no other means of support, an opportunity to see a dentist, gynecologist, dermatologist, a general practitioner, cardiologist, and an orthopedist. After our patients see their doctor, our bus takes those with prescriptions to a local pharmacy to pick up their treatment. These pharmacy costs are also fully covered by FRRME.

We often end our morning at the clinic by praying together. People then return home with medicine in hand, healthy teeth, small surgical procedures performed, tests read, check-ups had, and a greater peace of mind and body.

AUGUST 20, 2015 Dear Friends,

What has the summer looked like for our young Iraqi friends now displaced in Jordan?

To attend a Jordanian school, Iraqi refugee children must have their test scores and registration documents. Unfortunately, having fled the violence in Iraq, many children do not have this documentation. One of the goals at FRRME's school – the Marka Learning Centre – is to help get these documents back in the hands of the students that need them. The Iraqi government visited our school and agreed to testing the students in order to give them the paperwork they need in order to enroll locally.

The test administered by the Iraqi government comes at the beginning of September and the students have been diligently preparing, even through the summer break. The children will then return again for regular school as the Autumn term begins. Some will return to the Marka Learning Centre, while others will be able to attend local Jordanian schools. Either way, Iraqi refugee children have an opportunity to gain an education.

In addition to education, the Child Sponsorship Programme is designed to cover a student's basic living needs. Because Iraqi citizens – no matter what their previous profession in Iraq – can't legally be employed in Jordan, there is no way for a family to provide for themselves. This is intentional, so as to encourage their relocation elsewhere.

These basic needs, which are being met my FRRME, are the most urgent at hand. We're providing safe housing for the children, food coupons that allow families to do their own shopping, and vital health care. We also meet together as a church body.

Without this support, circumstances for refugee families here in Jordan can be dire. The families we work with left their homes, jobs, and possessions in a moment of chaos and alarm in Iraq. They came to Jordan with the clothes on their backs, the money in their pockets, and their lives. Any money they had in Iraqi banks was lost. The few that were able to bring money with them have by now run out.

Through FRRME's work, families know they have not been forgotten, that they are not alone, that God is with them.

Another aspect that must be understood when learning about the children's lives here in Jordan is the transience of being a refugee. No Iraqi refugee can make a plan to remain in Jordan – it is simply not an option. And so the lives of the families here are lived in this unknown, pause-like state with no work, no direction, and little hope for relocation to another country unless immediate family is already there.

I am happy to write that three families that are good friends of FRRME have recently been granted the opportunity to relocate to other countries such as Canada, the U.S and France, but these instances are few and far between.

When people are only waiting to leave a place, it affects everything; whether or not they seek to build relationships or invest themselves in a local church – it leaves people constantly wondering when, or if, they will ever get to leave.

Our families truly need places outside of Jordan to call home. Even though each new place would bring with it challenges of its own, at least it would be a place they could settle down in the long term. In the meantime, FRRME is making a real difference to the lives of Iraqi refugees here in Jordan.

## Ministering Children

This is a 408 page book with 26 chapters.

I came across this book while doing some research on the author Lucy Bethia Colquhoun. In her autobiography she mentioned this book as one that made a great impression on her as a wee girl. Now at the time of writing she is a much older women but she said that she thinks this is still a book every child should read. My interest was tweaked and so I found the book. I confess to agreeing with

her and so I thought I'd include the brief Preface and the first chapter for you to read here...

#### Preface

Difficulty being sometimes felt in training children to the exercise of those kindly feelings which have the Poor for their object, it was thought that an illustrative tale might prove a help toward this important end. It must be allowed by all, that the present is a day of increased exertion in behalf of those who are in need; but much care is necessary that the temporal aid extended may prove, not a moral injury, but a moral benefit, to both the receiver and the communicator of that aid. May it not be worthy of consideration, whether the most generally effective way to insure this moral benefit on both sides, would not be the early calling forth and training the sympathies of children by personal intercourse with want and sorrow, while as yet those sympathies flow spontaneously. Let the truth be borne in mind, that the influence of the giver far exceeds that of the gift on the receiver of it; and it must surely then be admitted, that in all aid rendered to others, the calling into exercise the best feelings of the heart, in both the giver and the receiver, is the most important object to be kept in view. To this end it is necessary that the talent of money be not suffered assume any undue supremacy in the service of nonviolence. Let children be trained, and taught, and led aright, and they will not be slow to learn that they possess a personal influence every where; that the first principles of Divine Truth acquired by them, are a means of communicating to others present comfort and eternal happiness; and that the heart of Love is the only spring that can effectually govern and direct the hand of Charity.

Chapter 1

Oh! say not, dream not heavenly notes To childish ears are vain; That the young mind at random floats And can not catch the strain. Dim or unheard the words may fall, And yet the heaven-taught mind May learn the sacred air, and all The harmony unwind."

And this is the confidence that we have in Him, that, If we ask any thing according to His will, He heareth us." —1 John, v. 14.

THE chimes of the great church clock in a large old town were playing a quarter to nine, on a bright September morning, when a little school-girl, shutting her mother's door, came stepping down the long dark flight of stairs at the top of which she lived; she wore no shawl, or cloak, or bonnet; a frock of dark brown stuff, a little white linen apron tied round her waist, a white linen tippet, and a little fine linen cap with a single border crimped close round her face; this was the little schoolgirl's dress. Ruth did not answer so many questions as some of the other children; she never spoke unless she was asked, and then she answered so softly, that no one but the lady heard; but the lady always seemed to smile at Ruth when she did answer, as if she had answered right. When the great church clock struck twelve, the lady went away; and the children put up their books into their bags, and went to their homes. Ruth could not stay with the sick child till she had asked her mother; hut she thought she would just look in, and tell her she was come back. Ruth looked in, and the child was tying quite still in bed; she did not speak, so Ruth went up and stood beside her.

"Oh! I am so glad you are come!" said the poor child; "what a long time it was you kept at school! Oh! I want something so bad! I can't eat this bread mother left me, it's so hard, it hurts me when I try."

"I have not had any food to-day," said little Ruth.

"O dear," said the sick child, "how bad it is! what do you do when you have no food?"

"I tell Jesus," said little Ruth.

"Who do you tell?" asked the poor child.

"Jesus," said little Ruth.

"Who is Jesus?" asked the poor child.

"What! don't you know who Jesus is?" said little Ruth. "I thought every body knew that except the poor heathen. He Is our Saviour?"

"Does He give you some food?" asked the poor child.

"O yes, He. often sends us some food when mother has nothing: but I must go to mother now, or she will scold."

"Do ask her to let you come and stay with me," said the poor child.

"Yes, I will," replied little Ruth; and she went up the high stair-case to her mother's room; she did not run with light quick steps, like children generally; but she went up slow and faint; for it was not one day alone, but many days, that little Ruth went to school without food. She had lost her own father: the father she now had was not her own father, and he thought only of himself and his own wicked pleasures, and left his wife and her children without food. But little Ruth had learned to pray; the lady who came to the school taught her from the Bible; and she had learned to know the love of God her Saviour; she loved and trusted Him, and, as she said in her own words, when they had no food "she told Jesus." .

When Ruth went into her mother's room, she saw on the table a can of steaming soup. "O mother! is that for us?" she asked. "Yes, to be sure it is. Miss Wilson sent it in this minute." Miss Wilson was the lady who came to the school. Ruth had not told Miss Wilson about their having no food that day; so

As she got near the bottom of the stair-case she stepped quicker in her eager haste; then, pushing open the door, she went in saying, "See here, Miss Wilson sent us this beautiful soup, and mother's given me some for you!"

"O dear, how nice! how glad I am!" said the poor child.

"Have you got a bason?" asked Ruth.

"Yes, there's one in that closet, and a spoon too," said the child.

Ruth found a small yellow bason and a spoon: she broke up the child's dry bit of bread in the bason; poured some of the hot soup over it; folded her hands, and asked a blessing in the name of Jesus; and then the two children dined together. Poor Patience had no comforter, no blessed ministering child had been yet to her. One day as Patience was walking to school, a little companion came and walked by her side—a rosy-faced child, eating bread and butter, finishing her breakfast on the way to school. Poor Patience had had no food that morning, she would have been so thankful for part of the child's bread and butter; but she did not ask for any, and when they reached the school, the child threw all she had left of it to a fat black goat who lived at a stable close by. The black goat tossed his head, and eat it up. Then poor Patience said, "O Nancy, how glad I should be of the food you waste!" and she stood watching the black goat eating up the bread and butter. But Nancy was not like little Ruth, she was not a ministering child, and she ran up the steps into the school, and thought no more of her bread and butter, and her little hungry school-fellow.

Irena Sender Died: May 12, 2008 (aged 98) Warsaw, Poland



During WWII, Irena, got permission to work in the Warsaw ghetto, as a Plumbing/Sewer specialist. She had an ulterior motive. Irena smuggled Jewish infants out in the bottom of the tool box she carried. She also carried a burlap sack in the back of her truck, for larger kids. Irena kept a dog in the back that she trained to bark when the Nazi soldiers let her in and out of the ghetto. The soldiers, of course, wanted nothing to do with the dog and the barking covered the kids/infants noises.



During her time of doing this, she managed to smuggle out and save 2500 kids/infants. Ultimately, she was caught, however, and the Nazis broke both of her legs and arms and beat her severely. Irena kept a record of the names of all the kids she had smuggled out in a glass jar that she buried under a tree in her back yard. After the war, she tried to locate any parents that may have survived and tried to reunite the family. Most had been gassed. Those kids she helped got placed into foster family homes or adopted.



In 2007 Irena was up for the Nobel Peace Prize. She was not selected. Al Gore won, for a slide show on Global Warming. Later another politician, Barack Obama, won for simply being the first black president.

## Religion

#### A Concise System of Theology

On the Basis of the Shorter Catechism by Alexander Smith Peterson, A.M. (1881).

While working on a biography of a missionary I first came across reference to this book which was made in very complimentary terms. I thus thought I should try and find it and having found it have added it to my Religious section of my Electric Scotland web site.

I thought this might be of interest to some of our Knights and Dames and so include mention of it here.

In the Preface it says...

THE Author of the following work, Mr ALEXANDER SMITH PATERSON, was the elder son of the late Rev. Alexander Paterson of Dundee, and nephew of the Rev. Dr Paterson, one of the ministers of Montrose. He was educated at the Grammar School and Marischal College, Aberdeen, where his family resided after the death of his father. Although a singularly laborious student, he evinced no small anxiety in the prospect of appearing before the Presbytery for examination. This apprehension was, in a great measure, the occasion of leading him to draw up very ample notes on the topics connected with Ecclesiastical History, which were afterwards posthumously published under the title, "History of the Church from the Creation of the World to the Nineteenth Century." The present work was composed with a some what similar object; and it is supposed that the intensity of mind which he brought to bear on both, in some measure hastened his premature and lamented death, which took place on the 12th of September 1828, in the 25th year of his age. The "Analysis of the Shorter Catechism" was left by Mr Paterson in a state of entire preparation for the press, but various circumstances have delayed its publication. It is now presented to the public entirely on account of its intrinsic merit. The manuscript was submitted to several distinguished ministers, who expressed their opinions in terms of the most ungualified approbation. In particular, the Rev. Dr Brewster of Craig described it "as being one of the most beautiful, complete, and accurate expositions of the Shorter Catechism which has ever appeared, unfolding the meaning of the answers to each question, with a clearness and minuteness of detail hitherto unequalled in works of the kind." Another gentleman of great literary experience, stated, that it "had been prepared with such elaborate care, that, after a critical perusal, he could not suggest the addition or diminution of a single word." Strong as these testimonies are, the Publisher confidently anticipates that they will be amply borne out by an examination of the work itself.

The annexed admirable Paper on the History and Arrangement of the Shorter Catechism, by the Rev. Duncan Macfarlan of Renfrew, appeared some time ago in a periodical publication, and is transferred into this volume with the obliging permission of the author.

#### **Robert Collyer**

In the biography mentioned above the sermons of this American Minister were also quoted as being inspiring and so again I looked for and found two books of his sermons. Here is a bit about him...

Collyer was born in Keighley, Yorkshire, England, on December 8, 1823; the family moved to Blubberhouses within a month of his birth. At the age of eight he was compelled to leave school and support himself by work in a linen factory. He was naturally studious, however, and supplemented his scant schooling by night study. At fourteen he was apprenticed to a blacksmith, Jacky Birch—who had taught the trade to Samuel Collyer, Robert's father, in Blubberhouses–and for several years worked at this trade at Ilkley. In 1849 he became a local Methodist minister. In the same year, his wife Harriet died on 1 February, and his infant daughter Jane on 4 February.

In the following year emigrated to the United States, where he obtained employment as a hammer maker at Shoemakersville, Pennsylvania. Here he soon began to preach on Sundays while still employed in the factory on weekdays. His earnest, rugged, simple style of oratory made him extremely popular, and at once secured for him a wide reputation. His advocacy of anti-slavery principles, then frowned upon by the Methodist authorities, aroused opposition, and eventually resulted in his trial for heresy and the revocation of his licence. He continued, however, as an independent preacher and lecturer, and in 1859, having joined the Unitarian Church, became a missionary of that church in Chicago, Illinois working as the first minister-at-large of the First Unitarian Church of Chicago. In 1860 he organized and became pastor of the Unity Church, the second Unitarian church in Chicago. Under his guidance the church grew to be one of the strongest of that denomination in the West, and Collyer himself came to be looked upon as one of the foremost pulpit orators in the country. During the American Civil War, he was active in the work of the Sanitary Commission. In 1879 he left Chicago and became pastor of the Church of the Messiah, now renamed the Community Church in New York City. Later he brought his old friend, the popular writer and hymnodist, Minot Judson Savage, to assist him in his ministry. In 1883, when he visited Birmingham in England, he engaged Marie Bethell Beauclerc to report and edit his sermons and prayers which were published during the same year. In 1903 Collyer became pastor emeritus. He died in 1912.

#### **Dugald Buchanan**

Finally, I was doing research on Dugald Buchanan, the Sacred Bard of the Scottish Highlands, and I quote this wee bit from his biography...

He was at the same time introduced to David Hume, who maintained, in conversation with him, that, although the bible was an excellent book, it was surpassed in beauty and sublimity of language by many profane authors. In support of his assertion, he quoted the lines –

" The cloud-capt towers, the gorgeous palaces, The solemn temples, the great globe itself; Yea, all which it inherit, shall dissolve, And, like the baseless fabric of a vision, Leave not a wreck behind."

The devout bard admitted the beauty and sublimity of these lines, but said, that he could furnish a passage from the New Testament still more sublime, and recited the following verses: (Rev. xx. 22.) "And I saw a great white throne, and him that sat on it, from whose face the earth and the heavens fled away; and there was found no place for them. And I saw the dead, small and great, stand before God; and the books were opened: and another book was opened, which was the book of life: - And the sea gave up the dead which were in it; and death and hell delivered up the dead which were in them: and they were judged every man according to their works."

"La a' Bhreitheanais" which was translated from the Gaelic into Scots by James Robertson. This long poem on the final confrontation between God and sinner is generally regarded as Buchanan's masterpiece. A terrifying and dramatic vision of eternal punishment.

## What are we to do with all the refugees?

I really think it is time that we had a whole new look at the refugee crisis and as I have some thoughts on this thought I'd share them with you.

I know when I first came to Canada I learned of the settlement at Elliot Lake where the town was created for the mining industry. When the mines closed the town was virtually a ghost town but then Retirement Living decided to purchase the town. I understand a 3 bedroom home could be purchased for \$35,000 in those days and they already had an infrastructure such as a medical centre, school, etc. I later learned of another such town, the name escapes me at the moment, but it was a similar situation.

I thus wondered if there were other such towns in Canada where this situation exists and thus might be converted to take in refugees. And by refugees I mean the people that are fleeing their homes due to war such as in Syria. As I understand it these people just want to be safe but would return to their homes when it was safe to do so. This means we would be looking after refugees that don't want to settle in other countries and do want to go home but in the meantime just need to be safe while the world sorts out the mess that caused all this.

I then further considered how in America and in Europe there must surely be old communities that

have been in decline and have lots of empty real estate such as Detroit. Could they not take in these people? Mind that most of them are ordinary people that would likely look after such homes to ensure they have a safe life for their families. Having people live there would surely help to improve the housing stock as left empty the homes would just fall down.

Then I wondered about old army camps. Some of them had to look after the soldiers and their families so also had amenities for families. Surely there must be some that are now empty that could be used to house these families?

The next thing I considered was to force a section of land in the Middle East to be a safe zone...

Perhaps a section of Syria where we could protect it by air cover and troops on the ground. This would be a more local safe zone where people could live in safety. I suspect that Europe or indeed China would police the area. In some respect China might be a good choice as they have no history in that part of the world and it is time that they contributed something to this disaster instead of sitting on the sidelines.

I even started to wonder if the world should take over Gaza and thus police this area as an Independent neutral zone. I mean by this that there is no way Israel and the Palestinians are going to agree on a two state solution when Israel has an enemy right on their doorstep. Ban all military and political movements and let the UN police it as a safe haven.

With the billions being spent to manage these refugees surely we could do something different to make sure these families are safe?

Now having got them somewhere safe with shelter, food, medical and education then we might explore how they could contribute back. My view if that most of these families want to earn a living so at the very least I'm sure they would want to contribute something back to the country that shelters them. Might we find work that would contribute to the country without causing unrest in the country? We're bound to get some resentment from locals saying they are being better looked after than they are. This is of course an area of possible contention but remember this is meant to be a temporary situation (possibly some years) but they will be returned home eventually.

I noted the other day that in Northern Scotland there are some 300 teachers posts vacant as they just can't find teachers to fill those posts. There must surely be other such cases in other countries where finding workers is an issue. Perhaps this would allow some latitude to providing jobs for those refugees while they are waiting to return home? They would then pay taxes on their income which would contribute back to the country that looks after them.

I do feel Europe and the EU in particular simply have no ideas on how to resolve this issue and frankly they are starting to look like real idiots in the process.

How might the Templars get involved in this? It seems to me from the very little I know that the Templars are more concerned with churches than people. So perhaps with all our contacts we might look at how we could acquire some land where we could settle some of these refugees and show by example how the situation could be improved in a minor way. This could be an example for a much greater effort. In our history we shed blood defending Christians in the Holy Land so why can't we do more ourselves? We were also master merchants and through trade and banking we almost ruled all of Europe. So why can't we do some commercial activity and invest in a project where by example we can show the world how to do things better?

I would also make a plea to our OSMTH leaders to create a project that the whole order can get behind and that we can talk about.

# How Modern History Symbolism Interpretations can destroy the future of Core Christianity Symbolism

Wolter has presented that the first thirteen states of the United States along with the 13 Stars & Stripes flag symbolism all represents thirteen for the letter "M" in the Alphabet for Mary. Over the last ten years of researching the United States great seal engraver Robert Scot of Edinburgh Scotland, I became very familiar with a symbol he always used, the letter "E", whether it is found on stone art, engraved relics, paintings, books, coins, wood carvings, painted fags and countless religious artifacts.
